**CORRIGENDUM No. 1**

**Notice seeking quotations for hiring of cleaning and hygiene services at Consulate General of India, Durban, 1 Kingsmead Boulevard, Kingsmead Office Park, Durban-4001**

2. The Consulate has decided to add one more criteria for submission of Performance security deposit to fulfill Financial Eligibility criteria. The additional financial eligibility criteria is as follows :

The successful bidder has to deposit Performance Security which will be a sum equivalent to 5% of the accepted contract value in favour of Consulate General of India, Durban in form of Bank Guarantee/Fixed Deposit Receipt (FDR), within two weeks from the date of award of contract.

ii) Performance Security should remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the service provider. In case, the contract is further extended beyond the initial period, the Performance Security will have to be renewed accordingly. No interest shall be paid on Performance Security.

lii) The Performance Security will be forfeited by order of the Competent Authority in the Consulate in the event of any breach or negligence or non-observance of any terms & conditions of the contract or for unsatisfactory performance. On expiry of the contract, portion of the Performance Security, as may be deemed fit by the Consulate sufficient to cover any incorrect or excess payments made on the bills to the firm, shall be retained.

iv) On due performance and completion of the contract in all respects, the Performance Security will be returned to the Service Provider without any interest on presentation of an absolute 'No Demand Certificate' from the Service Provider.
